MEMORANDUM OF UNDERSTANDING

AN AGREEMENT is made on _______ day of two thousand and ten (2010) between National Bureau of Soil Survey and Land Use Blanning (NBSS & LUP, ICAR), having its Regional Centre at Kolkata & Department of Agriculture, Govt. of West Bengal.

WHEREAS the NBSS & LUP (ICAR), Nagpur as well as its Regional Centre, Kolkata engaged in Research and Education on the field of Agriculture throughout the Eastern Region of the country and is an ICAR Institution.

AND WHEREAS Department of Agriculture, Govt. of West Bengal is responsible for agriculture development in the state of West Bengal. It is recognized that NBSS & LUP & Department of Agriculture have common

"Land Resource Inventory and GIS Data Base for Farm Planning in Coastal Region of West Bengal" particularly for wasteland development, strategic planning for land use, efficient cropping zones, Kisan soil health card, fertilizer recommendation, proactive advise to farmers and monitoring the state of health of natural resources. To this end, Strengthening of Research and Extension activity through Scientist's participation is agreed upon among two parties (as stated above NBSS & LUP (ICAR) and Department of Agriculture, Govt. of West Bengal). The purpose of this agreement is for Department of Agriculture, Govt. of West Bengal to finance the project wise estimated budget framed by NBSS & LUP to achieve the goal.

AND WHEREAS it is now thought necessary to specify basic terms and conditions agreed upon among the NBSS & LUP and Department of Agriculture, Govt. of West Bengal.

Now it is hereby mutually agreed and declared by and between among parties here to as follows:

As per the financial approval obtained for the projects, Department of Agriculture, Govt. of West Bengal shall pay the amount in two installment, first during 2010-11 amounting to Rs.26.00 lakh & second Rs.35.00 lakh during 2011-12 to the Director, NBSS & LUP, Nagpur for carrying out proposed work on "Land Resource Inventory and GIS Data Base for Farm Planning in Coastal Region of West Bengal (1:12,500 scale) towards Optimum Land Use Plan" in the State of West Bengal. The total project work will be undertaken in seven (7) Blocks consisting the districts of South & North 24-Parganas & Purba Medinipur of the State and will be completed within a period of two years as agreed.

Department of Agriculture, Govt. of West Bengal shall not entertain any excess expenditure from the provision made in the agreement for any sub-project unless prior approval is taken from Department of Agriculture, Govt. of West Bengal.

The provision of fund for the 2nd Installment i.e. during 2011-12 is subject to availability of RKVY fund from Govt. of India.

The assets created out of this project will be the property of Department of Agriculture, Govt. of West Bengal. In no case the assets created should be disposed of or transferred. After completion of the project Department of Agriculture, Govt. of West Bengal will have the right to return back the assets for the interest of public service if necessary. In case of any failure or incompletion of the project Department of Agriculture will have every right to return back of instruments/equipments purchased in this project.

The research programme shall be reviewed jointly by Department of Agriculture, Govt. of West Bengal & NBSS & LUP on quarterly basis and progress report should be submitted to the Department of Agriculture, Govt. of West Bengal.

Department of Agriculture, Govt. of West Bengal shall be at liberty to revoke and/or cancel the agreement contemplated here at any point of time by giving three months notice or its intention to do so, to the NBSS & LUP (ICAR).
