
ARTICLE 1



3. Both MPUAT and ICAR-NBSS&LUP may add, modify, amend or delete any part of this agreement by signing authorities with mutual consent and understanding, and as per the guidelines issued from ICAR, New Delhi from time to time.
4. Either party may terminate the agreement by written agreement signed by the appropriate official of the institution initiating the notice. Such notice may be received either party by thirty days (30) prior to the effective termination date.


